Introduction

This is a CPCAB Validated Course and is for people over 19 who want to take the next step in training to become a counsellor, having already acquired counselling skills, learning more about counselling theory and agency work. CST-L3 is an experiential course which is focussed on integrating theory and practice, starting to see counselling skills in context.

The learning on the course is about developing your ability to form and maintain a therapeutic or counselling relationship, understanding how theoretical perspectives underpin this. You will also be learning about the differences between a therapeutic relationship and the therapeutic process /outcome. It does not qualify you to practice as a professional counsellor.

The CST-L3 qualification is one step in a series of CPCAB qualifications. Once you have completed this qualification you wish to begin training to become a counsellor, in which case the next step on from CST-L3 is CPCAB's *Level 4 Diploma in Therapeutic Counselling (TC-L4)*. Progression is not automatic.

Placement

As part of this course there will be a placement requirement of 20 hours. This is a placement outside of the course where you can practice some of the skills used by counsellors but is not formally contracted counselling. Working with family and friends is not sufficient to meet the criteria for a placement. A placement is a situation in which you take on a helping role that involves the use of counselling skills. This might be within your paid employment if your work requires a helping role, such as a nurse, pastoral work as a teacher, carer etc. It does not apply to paid employment where the focus is not helping – for example shop work, bar work, hairdressing etc. You will need to research agencies or charities where you may become a volunteer in good time for starting the course. You will need DBS checks etc. which can take time, and you may be required to do some specific agency training.

Entry Requirements

Age 19 or over. Candidates are required to have undertaken counselling skills training – e.g. CPCAB's *Level 2 Certificate in Counselling Skills (CSK-L2)* or equivalent units / qualifications consisting of at least 75 GLH. You will be asked to attend a brief informal interview and will require a supporting reference from your Level 2 tutor.

Selection for enrolment may include factors such as:

Ability to cope with course content.

Ability to benefit from self- development.

Motivation towards developing as a helper / counsellor.

Emotional stability.

Evidence personal insight

Ability to form a counselling relationship.

Identification of reasons for training beyond just personal development

Reference from a previous Tutor.

Awareness of difference and diversity.

Attendance

A minimum of 80% attendance each term is required to successfully complete the qualification which involves 90 guided learning hours, delivered weekly as 3hour sessions for 28weeks & 1 x Saturday of 6hrs between November and July.

Assessment

Your learning will be assessed formatively by your tutors, your peers, and reflective self review. You will also be required to build a portfolio of evidence of your learning which will form the final internal assessment. In addition to this you will be externally assessed by the awarding body under exam conditions via an Exam Paper as per the current conditions. (Subject to changes)
Internal assessment will include at least 3 written assignments and an audio / visual recording of your practice, plus completion of exercises set.
